### ABOUT THE CRIME – ARMED ROBBERIES

This alert gives notice of recent armed robberies with handguns in the Bucktown, Logan Square & West Town neighborhoods in the 12<sup>th</sup> (Near West), 14<sup>th</sup> (Shakespeare) and 25<sup>th</sup> (Grand Central) Districts.

In the incidents below, unknown masked offenders and exit a vehicle, brandish black handguns, and demand personal property from victims. After taking the victim's belongings, the offenders returned to the vehicle and fled. The offenders were in stolen vehicles, including a grey Hyundai Sonata, black Hyundai Elantra, blue Kia Sportage and grey Kia Optima.

### **SOBRE EL DELITO – ROBOS A MANO MANO**

Esta alerta informa sobre robos a mano armada recientes con pistolas en los vecindarios de Bucktown, Logan Square y West Town, dentro de los distritos 12 (Near West), 14 (Shakespeare) y 25 (Grand Central).

En los incidentes a continuación, delincuentes desconocidos enmascarados salieron de un vehículo, blandieron pistolas negras y exigieron pertenencias personales a las víctimas. Tras robarles sus pertenencias, regresaron al vehículo y huyeron. Los delincuentes se encontraban en vehículos robados, incluyendo un Hyundai Sonata gris, un Hyundai Elantra negro, un Kia Sportage azul y un Kia Optima gris.
