Narrative: The above offenders were arrested on September 11, 2025, between 4:55 a.m. - 5:04 a.m., in the 500 block of N. Michigan Ave. (Offenders 1-5) and the 1400 block of S. Lake Shore Dr. Sb. (Offenders 6-7). They were identified as the offenders who, approximately 5 minutes earlier, took property from a business in the 900 block of N. Michigan Ave. (18th District). The offenders fled in multiple vehicles, including one that fatally struck a 40-year-old male driver in the 500 block of N. Michigan Ave. (18th District). Responding officers quickly located the offenders, who were placed into custody and subsequently charged accordingly. No additional information is available at this time.
