ABOUT THE CRIME – CTA ROBBERIES

This alert gives notice to recent Robbery incidents inside of commercial businesses in South Chicago, South Shore, Calumet Heights, Roseland, Jeffery Manor, Washington Heights, and Englewood neighborhoods within the 003rd (Grand Crossing), 004th (South Chicago), 005th (Calumet), 007th (Englewood), and 022nd (Morgan Park) Districts.

In these incidents, two to five offenders enter business establishments while armed with handguns and demand money from the cash registers. The offenders remove an undetermined amount of U.S. currency, and in some incidents take the cash registers or the victims' personal property before fleeing the scene in various vehicles.

OFFENDER DESCRIPTION

The offenders are described as two to five African American males and females wearing all black clothing. In one instance, one male wearing gray hooded sweatshirt and black pants, and one black male wearing a blue hooded sweatshirt.

- Immediately report suspicious activity.
- If you are confronted by an assailant remain calm.
- Remember any unique physical characteristics (scars, limp, acne, teeth, etc.).
- Never pursue a fleeing assailant; provide the information to the police.

- If approached by a witness to the incident, request their contact information.
- Immediately dial 9-1-1 and remain on the scene when possible.

Sobre el delito: Robos en la CTA

Esta alerta informa sobre incidentes recientes de robo en establecimientos comerciales de los vecindarios de South Chicago, South Shore, Calumet Heights, Roseland, Jeffery Manor, Washington Heights y Englewood, dentro de los distritos 003 (Grand Crossing), 004 (South Chicago), 005 (Calumet), 007 (Englewood) y 022 (Morgan Park).

En estos incidentes, entre dos y cinco delincuentes irrumpen en establecimientos comerciales armados con pistolas y exigen el dinero de las cajas registradoras. Los delincuentes se apoderan de una cantidad indeterminada de moneda estadounidense y, en algunos casos, se llevan las cajas registradoras o las pertenencias personales de las víctimas antes de huir del lugar en diversos vehículos.

Descripción del infractor

A los autores se les describe como un grupo de entre dos y cinco hombres y mujeres afroamericanos vestidos completamente de negro. En un caso concreto, se identificó a un hombre con sudadera gris con capucha y pantalones negros, y a otro hombre afroamericano con una sudadera azul con capucha.

QUÉ PUEDES HACER

- Manténgase siempre atento a su entorno.
- Informe de inmediato sobre cualquier actividad sospechosa.
- Si se enfrenta a un agresor, mantenga la calma.
- Recuerde cualquier característica física distintiva (cicatrices, cojera, acné, dentadura, etc.).
- Nunca persiga a un agresor que esté huyendo; facilite la información a la policía.
- Si dispone de videovigilancia, guarde una copia de la grabación del incidente para los detectives.
- Si se le acerca un testigo del incidente, solicítele sus datos de contacto.
- Llame inmediatamente al 911 y permanezca en el lugar de los hechos siempre que sea posible.
