**Department Commendation Award #8142054 is presented to Detectives Martin Brennan, Brian Daly, Darren Dehaan, Jeffrey Edwards, George Junkovic, Mark Mendoza, Daniel Schmit, James Schnier, Bernard Veleta, Police Officers David Carey, John Guettler, Kamil Kuczek, Gerald Lau, Jr., Erik Miehle, Daniel Netzky, and Anthony Pavone**

- On 05 DEC 2020, members of The Spanish Cobra street gang, while in their vehicle, pulled alongside innocent fifty-three year old homeless man Mr. Enrique Sanchez' vehicle and shot at victim approximately eighteen times; the victim died on scene.
- The Area Five Homicide Division and the Area Five Technology Center collected a substantial amount of video, eye witness, and electronic evidence via numerous search warrants and interviews; and as a result of their hard work the shooter was identified.
- On 13 JAN 2021, Area Five Homicide Gang Team #6550 conducted a surveillance in the 1600 block of north Latrobe which led to the location and arrest of said offender on the street.

**Special Commendation Award #8142464 is presented to Police Officers David Guzman and Darius Reed**

- On January 28, 2021 Officers Reed and Officer Guzman were on duty and working in conjunction with the Illinois State Police Narcotics and Currency Interdiction Team when they developed information related to a suspicious tractor trailer.
- Further investigation led to the recovery of approximately 1.5 million dollars USC, (31) kilograms of cocaine and (1) semiautomatic handgun, and as a result the above officers placed two involved offenders in custody.
- The investigation also revealed the cocaine had been shipped from El Paso, Texas and was intended for distribution in the area of 13th & Central Park in the 010th Chicago Police District.
