UPON ARRIVAL A/O'S OBSERVED A GROUP OF PEOPLE STANDING ON THE SECURED SIDE OF A MARKED BARRIER WHICH STATED NO TRESPASSING. All subjects were then INSTRUCTED MULTIPLE TIMES TO LEAVE THE AREA. DESPITE THIS several subjects REMAINED IN THE restricted AREA. EVENT #13395. B.W.C RECORDED INCIDENT BUT NOT REVIEWED. IN SUMMARY, R/O WORKING BEAT #CH105I WERE AT 1919 W MAYPOLE AVE (CITY OF CHICAGO PARK #578) PERFORMING CROWD CONTROL DUTIES FOR DNC DETAIL. R/O ALONG WITH FELLOW OFFICERS WERE CONDUCTING A PROTECTED LINE FOR ACTIVE PROTESTORS. OFFICERS GAVE MULTIPLE VERBAL COMMANDS FOR THE ACTIVE PROTESTORS TO MOVE BACK. AT WHICH TIME AT THE WEST END OF THE PARK [O] UNKNOWN 1, UNKNOWN 1 DISOBEYED OFFICERS VERBAL COMMANDS AND BROKE THROUGH OFFICERS PROTECTED LINE. OFFENDER THEN STARTED RUNNING HEAD FIRST TOWARDS [V] P.O RAKOCHYY, Y MAKING CONTACT WITH STOMACH AREA AND WRAPPING HANDS AROUND WAIST AREA CAUSING [V] P.O RAKOCHYY to fall to the ground which caused his head to strike the pavement. SUBJECT DUE TO HAVING ARMS AROUND P.O'S WAIST WAS ABLE TO UNHOLSTER p.o. Rakochyy's firearm. BEAT #CH105C, CH105G AND R/O ASSISTED WITH AN EMERGENCY TAKEDOWN of the offender. R/O Lorusso #16512 WAS ABLE TO RECOVER p.o. rakochyy's WEAPON. OFFENDER STIFFENED ARMS AND BECAME DEAD WEIGHT in an effort to defeat officers attempts to place him under arrest. NARRATIVE	Event #2423205741. In summary R/Lt is documenting this declaration of a Coordinated Mass Arrest on behalf of Chief DeVries #250. On the listed date and time Chief DeVries was the incident commander of the Democratic National Convention (DNC) security operational plan. During this event a protest march gathered at "Park 578" a Chicago Park District park. Enclosing the North border of Park 578 was an anti-scale fence erected by contractors of the USSS. At the listed address persons unknown breached the fence and entered Washington Blvd along with approximately 100 protestors. This portion of Washington BLVD was part of the secure perimeter established and secured by the USSS for the purposes of conducting the DNC. This breach led to a volatile situation at the listed location and incited the crowd within ?Park 578.? The breach also posed a safety risk to the secure site comprising of the USSS establish DNC security zone. In order to regain control of the situation and to mitigate further breaches of the security perimeter Chief DeVries declared a Coordinated Mass Arrest. It should be noted that the department had prepared for the possibility of a CMA and all support provisions for a CMA were pre staged. Additional details regarding this event documented in Detective Division supplementary reports and the arrest reports of the individuals arrest during the CMA event.

NARRATIVE	Event #2423307789. In summary R/Lt is documenting this declaration of a Coordinated Multiple Arrest on behalf of Chief DeVries #250. On the listed date and time Chief DeVries was the incident commander of the Democratic National Convention (DNC) security operational plan. During this event an unpermitted protest group gathered in the street at 500 W. Madison. At listed address persons unknown used two large signs to form a wedge and moved toward the line of police officers attempting to breach the line despite being given lawful commands to stop and disperse. The unknown individuals were given additional lawful commands to disperse at which time they continued to gather and began to burn American flags in the middle of a large crowd. During this time, they burned at least 3 flags causing a public safety risk to those in the crowd and the surrounding area. The individuals were given a dispersal order along with the dispersal route. In order to regain control of the situation and to mitigate further public safety threats Chief DeVries declared a Coordinated Multiple Arrest. It should be noted that the department had prepared for the possibility of a CMA and all support provisions for a CMA were pre staged. Additional details regarding this event documented in Detective Division supplementary reports and the arrest reports of the individuals arrest during the CMA event.

In summary, R/Os assigned to work in an enforcement capacity for the Democratic National Convention at the United Center were alerted by officers from the Intelligence Division that they observed the above four offenders dismantle a City of Chicago fence that was in place to set a perimeter for the Democratic National Convention. Upon breaching said fence, the above listed offenders trespassed on State supported land while signs were posted (complaints signed by Secret Service Special Agent McKnight) and in place stating no trespassing was permitted. At this time, Beat 7187 observed Officer Diarra (Victim) who was reassembling the above-described perimeter offense when offender MASSETH approached Officer Diarra and threw an unknown liquid substance onto his person. Beat 7187, 7147 and 7142 maintained visual of MASSETH and provided a description of the offender who located MASSETH at 162 North Wood and placed MASSETH into custody without incident. Surveillance officers maintained visual of Offenders NOUBANI, ALI and RIWAWI were located in a parking lot at 1720 West Washington Boulevard and placed into custody without incident. All offenders were transported to A/3 by Beats 6245J, 6502B, 6241H and 6246L.. Sgt Martinez of the Somax was contacted a preservation of incident was created.
