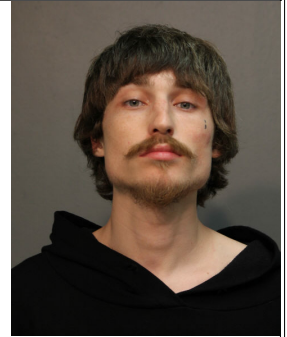

<b>INCIDENT NARRATIVE</b>	<p>(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)</p> <p>Event#12724. Arrest captured on BWC. In Summary: A/o's were assigned to work in an enforcement capacity for the Democratic National Convention, and were working a protest in the area of 500 W. Madison St. A/o's were alerted by Undercover Officers that Off. (Roger Palinsky M-2-27) was in possession of cans of spray paint and placed cans inside a black drawstring bag slung to his shoulders. UCO's kept a visual on the Off. who walked to the southeast corner of Washington Blvd. and Peoria St. A/o's were directed to the area observing the Off. A/o's approached the Off. who fled on foot eastbound. A/o's pursued Off. who abruptly stopped, turned towards PO Filetti #15785 taking a bladed stance with while raising clenched fists placing Po Filetti in reasonable fear of receiving a battery. While being placed into custody the Off. resisted A/o's in that he stiffened his body, pulled away, and refused to comply with verbal commands in attempt to evade an arrest. The Off. was placed into custody without further incident. A/o's transported the Off. to Area 3, while there a custodial search was performed. A/o's recovered from inside the black drawstring bag, 2 cans of spray paint (inventory 15578325) along with a sealed bag containing approximately 15 grams of cannabis inventory 15578373. Name check clear. Offender is currently on Parole through the Illinois Department of Corrections. Personal property inventory 15578307.
