EVENT #13764 THIS IS A BWC CAPTURED EVENT BY ASSISTING OFFICERS DUE TO THE FACT A/O'S ARRIVED ON SCENE TO PROCESS THIS ARREST AFTER SUBJECT WAS ALREADY PLACED INTO CUSTODY. IN SUMMARY ASSISTING OFFICERS RELATED THAT ABOVE SUBJECT WAS DRIVING ABOVE LISTED VEHICLE AND ENTERED INTO A SECRET SERVICE SECURE OUTER PERIMETER VEHICLE CHECKPOINT #1 WITH CLEAR SIGNAGE POSTED AND GAVE CONSENT TO A VEHICLE SEARCH. DURING SAID CHECKPOINT SEARCH SECRET SERVICE SPECIAL AGENT HUGHES OBSERVED IN THE TRUNK OF THE VEHICLE TWO HANDGUNS AND LIVE FIREWORKS. AT THIS TIME THE SUBJECT WAS DETAINED AND HELD FOR CPD. BTS X130 AND X122 RESPONDED, UPON THEIR ARRIVAL THEY PLACED SUBJECT INTO CUSTODY AT 2201HRS AND RECOVERED HANDGUNS AND FIREWORKS WHICH WERE FOUND TO BE ONE BLUE STEEL TAURUS 9MM MODEL G2C SEMI AUTOMATIC HANDGUN WITH A 3 INCH BARREL SERIAL #1C130993 EQUIPPED WITH A GREEN LASER MOUNTED SIGHT LOADED WITH 1 LIVE ROUND IN THE CHAMBER AND AN UNK AMOUNT OF ROUNDS IN THE MAGAZINE, ONE TAN SMITH AND WESSON MODEL M&P SHIELD PLUS SEMI AUTOMATIC HANDGUN WITH A 3 INCH BARREL SERIAL #JPJ3660 LOADED WITH 1 LIVE ROUND IN THE CHAMBER AND AN UNK AMOUNT IN THE MAGAZINE, 6 LIVE LOOSE ROUNDS, AND 1 EMPTY 9MM MAGAZINE, 3 ROMAN CANDLE FIREWORKS, AND 1 MS116A BOX FIREWORK. OFFENDER WAS TRANSPORTED INTO THE 001ST DISTRICT FOR PROCESSING, OFFENDER HAS ID WITH A CLEAR NAME CHECK DENYING ANY GANG AFFILIATION WITH NEGATIVE RESULTS FOR GIPP, TRAP AND INVESTIGATIVE ALERTS. SAID HANDGUNS INVENTORIED UNDER #155578327 AND #15578328, 6 LIVE ROUNDS AND MAGAZINE UNDER #15578329, SAID FIREWORKS INVENTORIED UNDER #155578295 , PRISONER PERSONAL PROPERTY INVENTORY #15578269, AND PRISONER JEWELRY #15578281 FELONY UPGRADE PENDING, OFFENDER MIRANDIZED BY P.O ARROYO #18464 AT 2323HRS AND HE INVOKED HIS RIGHT. CPIC, NEWS AFFAIRS, AND LEGAL AFFAIRS NOTIFIED AND PER LEGAL AFFAIRS NO ENHANCED CHARGING AT THIS TIME (2247HRS). OFFENDER HAS NO VALID FOID OR CCL.
