Burglaries and Thefts 014th, 017th, and 025th Districts (Grand Central)

About the Crime:

This alert gives notice to all businesses in the 014th, 017th, and 025th District, particularly those engaged in construction services, of recent burglaries and thefts of construction equipment, vehicles, trailers and tools. In these incidents, the offenders gain access to secured private lots by cutting the lock or the surrounding fencing, or that of adjacent properties. Once inside, the offenders take said equipment, sometimes loading onto a trailer attached to a maroon Chevy pick-up truck.

Two male offender: one male white, one male African American driving a maroon Chevy pick-up truck

Sobre el crimen:

Esta alerta notifica a todas las empresas en los distritos 014, 017 y 025, en particular las que se dedican a los servicios de construcción, sobre robos y hurtos recientes de equipos de construcción, vehículos, remolques y herramientas. En estos incidentes, los delincuentes obtienen acceso a lotes privados asegurados al cortar la cerradura o el cerco circundante, o el de las propiedades adyacentes. Una vez dentro, los delincuentes se llevan dicho equipo, a veces cargándolo en un remolque acoplado a una camioneta Chevy granate.
