### Juvenile Offender Charged with 16 Felony Counts of Aggravated Vehicular Hijacking, Armed Robbery



**Offender:** Male juvenile, 16

**Charges:** Eleven (11) felony counts – Vehicular Hijacking – Aggravated – Firearm  
Four (4) felony counts – Robbery – Armed with Firearm  
One (1) felony count – Attempt – Vehicular Hijacking – Aggravated – Firearm

**Narrative:** The above offender was arrested by members of the Vehicular Hijacking Task Force on January 12, 2023, in the 200 block of 69<sup>th</sup> Place. He was identified as one of the offenders who robbed multiple victims and took their vehicles by force while armed with a firearm. The incidents occurred within hours on August 20, 2022 at the following locations and approximate times:
