#### Narrative:

Hoskins, McDowell, Hunter, Woodard, a 17-year-old female juvenile and a 16-year-oldfemale juvenile were arrested after they were identified as the persons who recently committed robberies at two convenience stores. On February 1, 2016 at approximately 1:48 a.m. in the 0-100 block of E. Lake St., the offenders entered the establishment, pushed the store employee and fled with several items of merchandise. On February 9, 2016 at approximately 11:45 p.m. the offenders entered the convenience store located in the 800 block of S. State St. and announced a robbery. The offenders struck the store employee in the face and fled with merchandise. On February 10, 2016 at approximately 1:25 a.m., the offenders were involved in an armed robbery on the CTA Blue Line Train. A 28-year-old male victim was sitting on a train when he was approached by the offenders who struck the victim and took the victim's personal belongings. The offenders fled the scene and were apprehended near the Dearborn Blue Line stop. McDowell was also identified and charged in connection to a criminal sexual assault of a 26-year-old male victim that occurred on February 2, 2016 in the 300 block of S. Columbus Dr. at approximately 11:00 p.m. No further details available at this time.
