About the Crime:

This alert gives notice of recent Burglaries to businesses that have occurred within the boundaries of the 22nd District (Morgan Park). In these cases, the below described offender made entry to closed businesses by breaking the glass front door, or prying the rear door. The offender enters the establishments taking cash registers. Break-Ins occur between the hours of 3:00am and 6:00am.

Incident times and locations:

- December 28th, 2017 3:30am 11100 Block of S. Halsted
- January 8th, 2018 4:00am 9700 Block of S. Halsted
- January 8th, 2018 5:30am 9200 Block of S. Halsted

About the Offender:

One, male African American believed to 35 to 40 years of age. The offender was described as being approximately 5'10, 175lbs, wearing a baseball hat and gloves.

What you can do:

- Have a working alarm system in your business
- Keep a minimal amount of lights illuminated in your business during closing hours
- Keep cash hidden and secure while business is closed
- Consider installing video surveillance on the inside and outside of your property
- Maintain proper lighting over all entrances to your business
- Be aware of this crime and notify other businesses
- Call 911 immediately and provide a detailed description of any suspicious people including any vehicle description and license plate information
