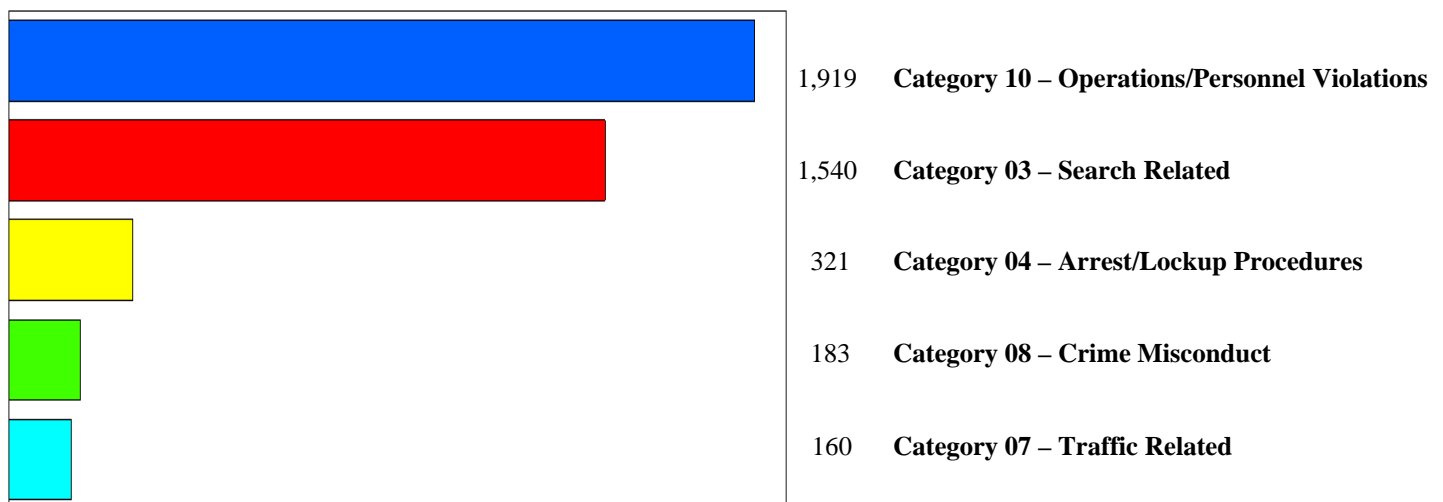
This newsletter contains a summary analysis of Complaint Logs received by the Chicago Police Department in 2009.

All received complaints are reviewed for responsibility to investigate. The Internal Affairs Division has the responsibility to investigate those allegations involving complaints of employee misconduct not assigned to the Independent Police Review Authority (IPRA). These allegations include but are not limited to; criminal misconduct, operational violations, substance abuse, and off-duty incidents that warrant department oversight.

Overall Citywide, in 2008 there were 9,769 complaint log numbers registered and 10,069 in 2009 with IPRA. The Internal Affairs Division was assigned 7,162 log numbers in 2008 and 7,233 in 2009 to evaluate.

The following data reflects those cases that were investigated by the Internal Affairs Division and does not include those cases that were Administratively Closed.

TOP FIVE ALLEGATIONS IN 2009 (Investigated by the Internal Affairs Division)

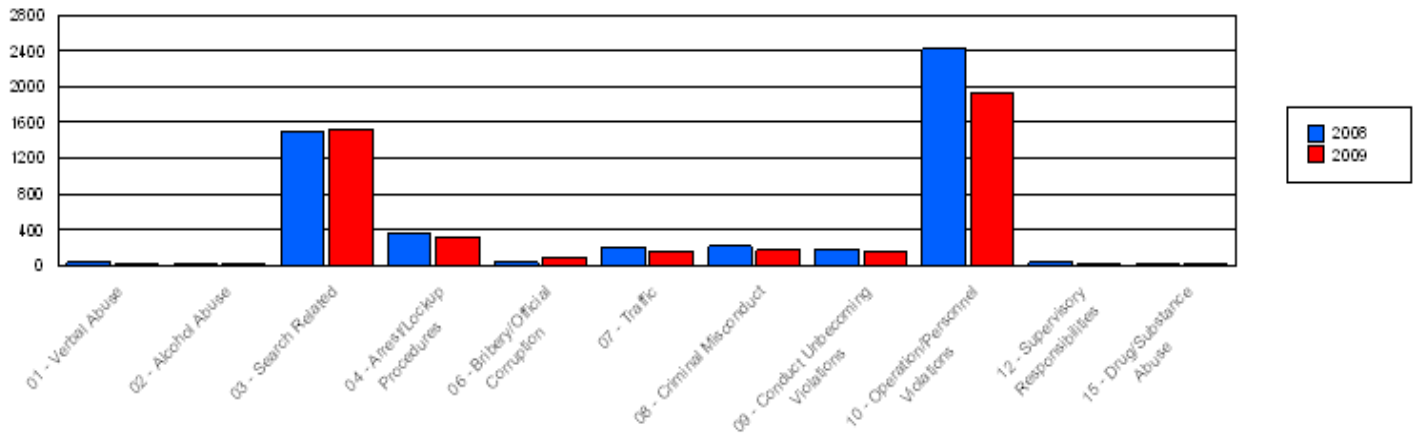
